LAPEER DAYS FESTIVAL 2025 - ARTS AND CRAFT GUIDELINES

Dear Crafter,

We are delighted to provide you with an application for the **Arts & Craft Show** at the **2025 Lapeer Days Summer Festival**. This festival is Lapeer County's **premier** summer event which annually draws thousands of people to the streets of downtown Lapeer over the weekend.

Please take note, a minimum of 80% of the items in your booth must be hand-made or home-made.
NO EXCEPTIONS!!

- **Due to many last-minute cancellations last year, payment is now due with application.** Checks and cash will be held and only deposited if you're approved. Card payments will have to be charged and then refunded if you are denied.
- The indemnification Agreement **MUST BE RETURNED WITH YOUR APPLICATION.**
- **The Arts & Craft Show is in Annrook Park along the sidewalk by the river.** It is strategically located between the main parking for the event and the Skerbeck Family Carnival. See attached map.
- Crafters must provide their tent, tie-downs, tables and chairs and any equipment needed.
- Exhibitors are responsible for their own insurance. ***If you sell a consumable or topical product, Clothing or toys, you MUST provide a Certificate of Liability Insurance with the Lapeer Area Chamber of Commerce and the City of Lapeer named as additional insured.***
- Vendors will leave the condition of the premises as found. Damages to any property will be paid for by the vendor.
- No lighting or electricity is provided. Absolutely **NO GENERATORS ALLOWED.**
- Vendors will be allowed to set up on **Thursday August 14th from 4pm to 8pm** and **Friday August 15th from 8am to 10am.** Friday morning all Crafter vehicles must be moved to legal parking areas no later than 10am.
- You must be set up and ready to open for business by 11:00 am Friday. **You must participate in all three days of the show.**
- **Friday, August 15, 11am-8pm, Saturday, August 16, 11am-8pm & Sunday August 17, 11am-5pm**
- Parking will be available in the park for ease of loading and unloading. Parking is on a first come first served basis for vendors and the public. Parking is only allowed in legal parking spaces.
- No overnight camping is allowed in the park.
- **All rights reserved by the Lapeer Days Festival Committee. Submission of the application is not a guarantee of acceptance to the show.**

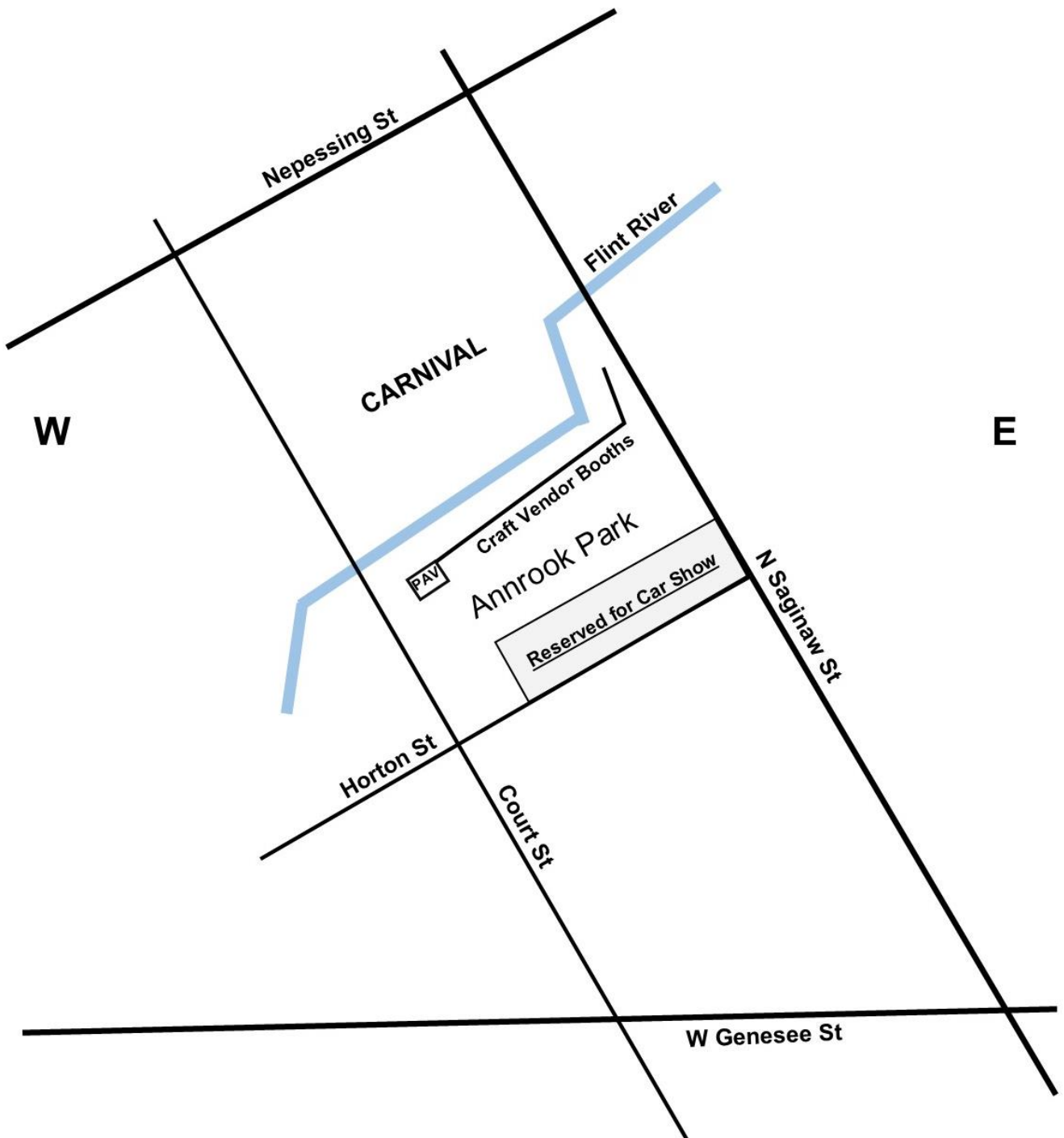
NO REFUNDS will be given for cancellations.
